# **Personal Data Protection Policy**

#### 1. Introduction

  - other lawful business activities of ExIS.
- 3.3 The personal data provided by you to ExIS may, if required, be disclosed to third parties.
- 3.4 Generally, the personal data processed by ExIS is collected from you or provided by a third party to ExIS for the aforesaid purposes.

### 4 Security of Your Personal Data
